Inhalation: If symptoms of poisoning become evident, contact a Poisons Information Centre 13 11 26, or call a doctor immediately. Remove source of contamination or move victim to fresh air. If breathing difficult, oxygen may be beneficial if administered by trained personnel, preferably on adoctor's advice. DO NOT allow victim to move about unnecessarily. Symptoms of pulmonary oedema can be delayed up to 48 hours afterexposure.

Skin Contact: Gently blot away excess liquid. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical isremoved.

Eye contact: Immediately flush the eye with lukewarm, gentle flowing water for 20 minutes or until the product is removed, whilst holding the eye open. Takecare not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care ifexposed person is wearing contact lenses.

Suitable extinguishing media: If material is involved in a fire use water fog (or if unavailable fine water spray), alcohol resistant foam, dry agent (carbon dioxide, dry chemical powder).

Specific hazards: Highly flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. Avoid all ignition sources. 7. HANDLING AND STORAGE

11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Acute Effects

Inhalation: Available data shows that this product is harmful. But symptoms are not available. In addition product may be mildly irritating, although unlikelyto cause anything more than mild transient discomfort. No data for health effects associated with long term inhalation. Inhalation of vapour can result in headaches, dizziness and possible nausea.
