**Skin Contact:** If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. ## 5. FIRE FIGHTING MEASURES

**Suitable extinguishing media:** If material is involved in a fire use alcohol resistant foam, standard foam or dry agent (carbon dioxide, dry chemical powder).

## 7. HANDLING AND STORAGE
