Section 4 - First Aid Measures

Inhalation

If inhaled, remove affected person from contaminated area. Remove contaminated clothing and loosen remaining clothing. Allow patient to assum most comfortable position. Apply artificial respiration if not breathing. Seek medical attention.

Keep containers exposed to extreme heat cool with water spray. Fire fighters to wear self contained breathing apparatus if risk of exposure to products of combustion or decomposition.

Section 6 - Accidental Release Measures

Spills & Disposal

Minor spills do not normally need any special clean up measures. In the event of a large spill, prevent spillage from entering watercourses. Wear appropriate protective equipment (as listed in Section 8 of this SDS) to prevent eye and skin contamination.

Spilt material may result in a slip hazard and should be absorbed into dry, inert material to be collected in appropriately labelled containers for disposal by an approved agent according to local regulations.

Store in a cool dry well-ventilated area. Do not store in aluminium or light alloy containers. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks.

Engineering Controls

Uses and Restrictions

For grease encrusted floors: Apply 200ml of product in 1 litre of water using a brush, - leave for 10-15 minutes, repeat brushing and hose off with water.

For general cleaning: Apply between 10 & 30 ml of product in 1 litre of water, depending on the soiling and the job.

Not recommended for cleaning powder coated colour bond or old paint work.

Rinse food contacting surfaces with potable water after use.
