

OXY-BRITE POWDER – Fully Built Hygienic Laundry Powder

DESCRIPTION

OXY-BRITE is a new generation laundry powder that has been developed as a simple, high performance alternative to complicated liquid dosing systems commonly used in commercial laundry facilities that typically use up to five different products. OXY-BRITE's innovative formula uses a dual bleaching system and offers effective emulsification for the removal of all stains.

OXY-BRITE is a biodegradable product that conforms to the Australian Standard for Laundry Practice AS/NZS4146, including broad spectrum disinfection at wash temperature less than 50°C.

DIRECTIONS FOR USE

For dramatically reducing bacteria counts: Manually dose or prepare stock solution for automatic dosing.
Dose into main wash. Temperature approximately 40°C.

Light soil: 5g/kg dry materials
Heavy soil: 10g/kg dry materials

HAND & SKIN CARE:
